This letter is in reference to getting a Domestic Personal Protection Order.

My name is Ami Moeller, I am requesting a PPO against Kevin James Lindke. Kevin and I have been together for 5 years. Within that time frame, there have been many physical altercations between us. I have been slapped, hit, shoved, thrown, choked, suffocated, he has held me down and spit on my face. There have been many instances where police were called, but I never chose to press charges. I am regretting that at this time.

We are currently going through a separation. Kevin has made many threats towards me in the past week regarding this. I recently filed for custody, to protect both our rights and to establish specific "Parenting Time" because unfortunately precedence tells me that I will not be able to work this through with him any other way. This has made him very upset, and has led to further harassment and threatening texts. He has also resorted to sending nude photos of me to my friends. I was told that a PPO could possibly protect me from similar occurrences in the future, as sending photos of me to third parties could be considered harassment and would violate a PPO.

Recently, in this past week, Kevin has also sent threatening texts to my mother and to my grandmother. Mostly telling them how I am fucked, how he is going to find me, and how I am going to pay.

On Sunday, 8/30/2015, when I met him to pick up my daughter in the Menard's parking lot he said to me, "You're lucky I don't beat the fuck out of you right now."

Some specific examples of text threats I have received in the past week. I will also try to attach in picture form:

Saturday, 8/29/2015- 9/4/2015

- "I'll be home tomorrow.... You better pray I don't see you when I get home."

- "I am going to fucking destroy you when I get back. So enjoy your last day of peace. When I get home, I am going to show you just how nasty I can really get. When I'm done with you, you're going to want to jump off a bridge... You've seen nothing in the last 5 years like you're going to see in the next few days. You will have nothing when I'm done with you.... I'm going to fuck you as bad as I've ever fucked anyone. You have some every bad shit coming your way. You better prepare for it."

- "You're about to see 5 years of resentment and hatred come full force with the singular goal of fucking up your life."

- "I am going to beat the fuck out of you when our paths cross."

- "And as far as the PPO goes, it's not going to protect you from shit once I decide it's time for payback. And trust me, one day I'll get you back. Show this to whoever you need to."

Friday, 9/4/2015: - "You can shove your protection order up your ass. I'll be coming for my daughter today. Call whoever you need to.... You don't get to take my daughter. I'm going to find you and you're going to pay... No piece of paper is going to protect you."

- Saturday 9/5 - Kevin showed up at my mother's - I was staying there with my daughter. honked on horn repeatedly. I called 911 not knowing what his intentions were.
- Sunday 9/6 - showed up at my mom's boyfriend's house (902 Merchant, PH) 9:30 (about) pm. Banging on front door - walking around house banging on windows. I called 911 again.
- Monday morning - showed back up @ mom's boyfriend's house. Banging on doors & windows. I called 911 again. He was told to leave.
- Tuesday Morning - Showed back up at mom's boyfriend's house again. was told to leave by mom's boyfriend - Steven Herthoff.
- returned an hour later once he knew Steve was gone. banged on doors & threatened to beat Steve up. officers reported to the scene. He was arrested - Stalking & resisting arrest.

Synopsis:

Petitioner and respondent had a live in dating relationship resulting in one minor child. Petitioner claims past domestic violence that she never reported and/or signed a formal complaint on. They have separated and petitioner's statement includes incidents of harassment, threats and use of social media to distribute photos of the petitioner. Respondent was arrested on 9/8/15 for stalking and resisting arrest at a home in Port Huron where petitioner was hiding out from him.

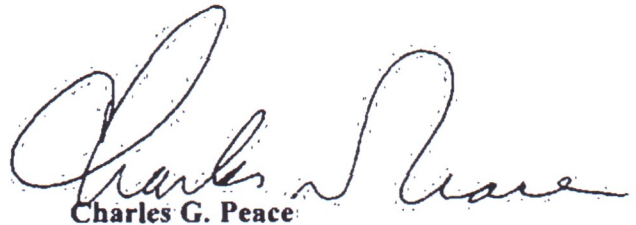
